## What is the purpose of the study?

- To support the development patterns of the CCIs within the EU through improved indicators on their performance;

## Do I have to take part?

No, your participation is completely voluntary, and you can decide not to take part.

## What will happen to me if I take part?

If you take part, we will invite you to participate in an interview with members of the DISCE research team. We may also include a translator if you require. The interview will last between 60 – 90 minutes and will take place at a mutually agreed location. The interview will be audio-recorded and transcribed. All personal information will be pseudonymised and the materials will be used as part of a study and report (as well as disseminated in academic conferences and journals). Your participation is voluntary and that you are free to withdraw at any time either prior or during the interview without giving any reason. However, you will not be able to withdraw your data after two weeks from the date that the interview was conducted.

#### What will the content of the interview be?

The interview will include questions on how you participate and engage in cultural and creative activities in your local area. We will also ask you some questions about your background, your education and your interest in cultural and creative activities. You are under no obligation to answer all the questions in the interview. Here is a general overview of the interview content:

- Your work or what you do day to day.
- Your educational background.
- How your work or day to day activities engage with creativity.
- Your motivations and goals in engaging with these activities.
- The rewards (economic and other) you get and contribution to your livelihood.
- Your networks (professional and social) in Enschede.
- Place and value of creativity in Enschede.
- The importance of technologies to your work and everyday life.
- Your views and definition of terms like entrepreneurship and growth which are central to the project.
- Your views and recommendation on local policy to support creativity in Enschede.

## **Data handling**

















Your data will be processed in accordance with the General Data Protection Regulation 2016 (GDPR).

- All interviews will take place at an agreed time and location at the participant's convenience.
- Recorded interviews and transcriptions will be stored on the DISCE secure online storage repository.
- Your data will be stored on the DISCE secure online repository for the duration of the research project.
- This data will only be shared with members of the DISCE research team.
- The data will be processed in the countries where DISCE research partners are based at, i.e. Finland, Italy, Latvia and United Kingdom.
- The interviews will be transcribed by an approved transcriber Spoken Oy Ltd. An agreement on the terms regarding the processing of personal data, which is in accordance with the EU Data Protection Regulations, has been made with the transcriber.

### **Data Protection Statement**

The data controller for this project will be Onerva Steudle of DISCE project at the University of Turku, Finland. The University will process your personal data for the purpose of the research outlined above. The legal basis for processing your personal data for research purposes under GDPR is a 'task in the public interest' You can provide your consent for the use of your personal data in this study by completing the consent form that has been provided to you.

You have the right to access information held about you. Your right of access can be exercised in accordance with the General Data Protection Regulation. You also have other rights including rights of correction, erasure, objection, and data portability.

#### Will my taking part be kept confidential?

Any public documents emerging from the interview (for example published research presentations, reports or journal articles) will be pseudonymised, unless you agree to identification. If you agree to identification, your views and quotes from the interview can be used associated to your name. If you prefer to remain anonymous, a pseudonym will be applied instead when quoting your own words or ideas.
